Hotel Terms and Conditions

Reservation

A hotel reservation made via the Sibos 2019 website is only considered valid and complete upon receipt of payment for your conference subscription by the Sibos Hotel Registration Office. Failure to (timely) pay your conference subscription may result in the cancellation of your hotel reservation by the Sibos Hotel Registration Office. You may be held liable for any applicable cancellation fees. Hotels only guarantee room reservations that are accompanied by a valid credit card. Therefore, you are required to submit your credit card details when making a hotel reservation through the Sibos 2019 website. The Sibos Hotel Registration Office will pass on your credit card details to the relevant hotel. However, no charge will be made to your credit card by the Sibos Hotel Registration Office. Please note that the hotel reserves the right to charge one night's accommodation to your credit card thirty days before arrival as a deposit. This deposit is non-refundable. If you wish to prepay for your entire stay 30 days prior to the event, please select the tick box on the credit card guarantee page authorising the hotel to charge a pre-payment for your entire stay.

Hotel Prices And Room Type

All prices are in Great British Pounds (GBP). The price quoted is per room per night. VAT is included in the rate. If breakfast is included in the rate, this is indicated on the website and in your hotel booking confirmation email. If breakfast is excluded, you will be charged separately for breakfast. The breakfast rate may be subject to change. A SINGLE room rate entitles one person to occupy the room for the duration of your stay. A DOUBLE room rate entitles two people to occupy the room for the full duration of your stay. Please note that you are responsible for settling all bills upon check out. If you fail to settle your bills, the hotel reserves the right to automatically charge the amount due to your credit card.

Cancellation Policy

By making a reservation with the Sibos Hotel Registration Office or through the Sibos 2019 website, you expressly agree to the following: In the event of a cancellation of a hotel reservation after close of business on Tuesday 20 August 2019 (17:00 CET), or in the event of a no-show or early departure, the hotel reserves the right to automatically debit your credit card for all reserved nights. If you are unable to arrive on the original date of arrival, you must inform the Sibos Hotel Registration Office in writing to hotels@sibos.com. If you fail to inform the Sibos Hotel Registration Office of your late arrival, the hotel will make reasonable efforts to accommodate you, but does not provide any guarantee to that end. Changes Until Tuesday 20 August, you can make amendments, changes or cancellations of your

hotel reservation through the Sibos 2019 website, without any additional charges. After Tuesday 20 August 2019, you must contact the Sibos Hotel Registration Office directly in order to make any changes or cancellations of your reservation. Such changes or cancellations may be subject to hotel charges. Therefore, we recommend that you check the arrival and departure dates carefully at the time of booking.
