

# Sibos Exhibitor Day | 24 March 2020 Terms and Conditions

Registration for and participation in Sibos Exhibitor Day are subject to these Terms and Conditions. By submitting your registration for Sibos Exhibitor Day, you will be considered to have agreed to these Sibos Exhibitor Day Terms and Conditions.

#### Interpretation

'Sibos Exhibitor Day' means an information session for Sibos 2020 exhibitors organised by SWIFT on 24 March 2020 at Boston Convention and Exhibition Center (BCEC) – 415 Summer St, Boston, MA 02210, USA

## **Registration Eligibility**

Sibos Exhibitor Day is exclusively open to representatives of exhibitors who are already registered for the Sibos 2020 event and who have already accepted the 2020 Terms & Conditions for Exhibitors.

#### **Procedure**

All registrations for the Sibos Exhibitor Day must be made in advance online via the official Sibos registration website only.

SWIFT then acknowledges receipt of registrations.

## **Event Cancellation, Postponement or Alteration**

If, for any reason whatsoever, SWIFT is forced to cancel, postpone or materially alter Sibos Exhibitor Day, in whole or in part, it will use all reasonable efforts to notify all registered participants reasonably in advance thereof.
