

Sibos Terms of use

These terms of use apply to the use of Sibos.com and Sibos Mobile Application (the "Tools").

Intellectual Property

The Tools contain proprietary materials of SWIFT SC and/or of its suppliers. All rights reserved. Any and all rights, including title, ownership rights, copyright, trademark, patents, and any other intellectual property rights of whatever nature, in the services or products described in these Tools, including any associated processes or any derivative works, will remain the sole and exclusive property of SWIFT and/or its suppliers.
